

Annual Bill Mosca Memorial Crappie Tournament

Sponsored by the Cannon River Sportsmen's Club

Date: Saturday, May 7th, 2022

Time: 9am - 2:30pm

***Must report to tournament headquarters before 8:15am**

Place: Cedar Lake (LeMieux's Resort) west of Faribault, MN off Rice Co. Hwy 38.

*All participants will **start** and **finish** the tournament at LeMieux's Resort landing on the north side of Cedar Lake.*

Cost: Entries are **\$75.00 per team**. Two anglers per boat.

The tournament will be **limited to 50 teams**.

DOOR PRIZES

- 1. Eligibility:** At least **one member** of each team must be **18 years of age or older**.
- 2. Location:** Official tournament headquarters and weigh-in-station will be at LeMieux's Resort.
- 3. *Reporting:** Anglers must **report to tournament headquarters before 8:15am** on the day of the tournament. Boat inspections and final rules meeting will occur at this time.
- 4. Hours:** Tournament fishing hours will run from **9am - 2:30pm**. **No practice fishing permitted on the day of the tournament!** Anglers are not permitted to depart from their watercraft at any time, **except** at tournament headquarters in order to use toilet facilities, weigh-in fish or purchase bait. Check with officials before deviating from above exceptions. **Teams that have not returned to the dock area by the 2:30pm deadline will be disqualified. Problems with your boat, motor, etc. will not be accepted as an excuse.**
- 5. Weigh-In:** Prize winners will be **determined by total pounds and ounces of crappies**. A maximum of **fifteen (15) crappies per team may be weighed**. **Culling or live well sorting is permitted. Fish weigh-in permitted once only. ALL TEAMS MUST WEIGH-IN ANY AND ALL CRAPPIES.**
- 6. Ties for total weight:** All ties will be decided by combining the money (prizes) and dividing it into equal shares (i.e. 3 teams - split \$270 = \$90 per team). Length of crappie applies only to the single largest fish category (length and weight). If a tie occurs in the largest crappie category, the above formula will be used to resolve the tie(s). Each team may weigh one (1) crappie to compete in this category - the anglers pick the fish they consider to be the largest.
- 7. Catch and Release:** All fish caught during the tournament may be released at the conclusion of the weigh-in. **HOWEVER, the use of an internal live well that recirculates the water is MANDATORY if the fish are to be released. All other crappies must be KEPT. Tournament officials - NO ONE ELSE will release fish into the main body of the lake.**
- 8. Rules:** Tournament officials will be enforcing the rules and reserve the right to examine all boats and fish. Disqualification will result if evidence reveals a violation of tournament rules or Minnesota fishing regulations occur.
- 9. Conduct and Safety:** Sportsmanship, courtesy, and safe boat handling is expected from all participants. **A 20 yard minimum distance must be maintained between anchored boats. Boats will not tie-up together during the tournament.**
- 10. Team/Boat Number:** All teams will be issued a team/boat number after entrance fees have been received. **A phone call with boat number will be made to each Team Captain. Bow streamers will be issued at the rules meeting beginning at 8:15am the day of the tournament.**
- 11. Eurasian Milfoil/Zebra Mussels:** All boats and trailers will be inspected before launching and again when departing the lake. All aquatic grasses, weeds, etc. must be removed. These **inspections will be performed by tournament officials and volunteer team members.**
